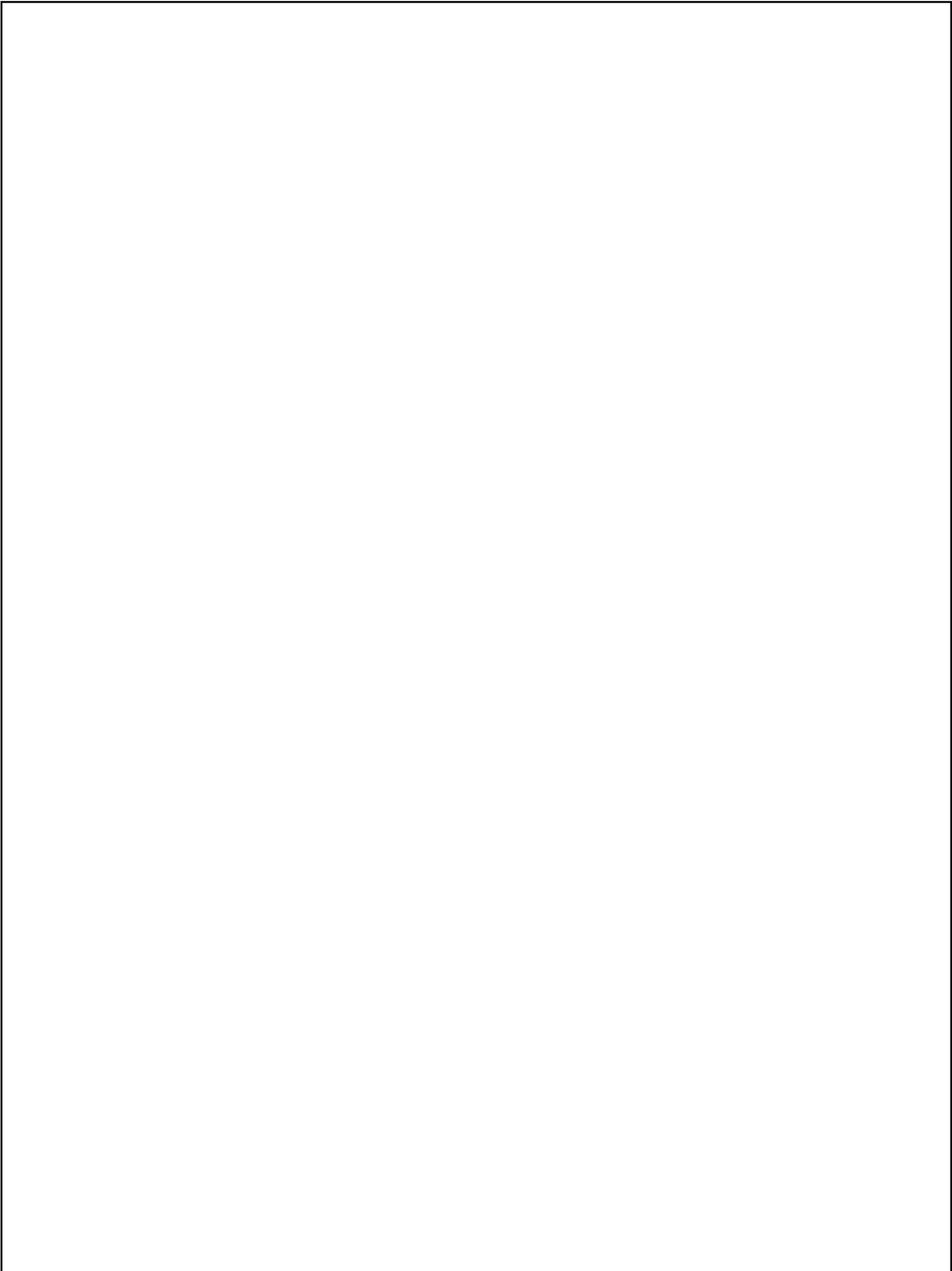

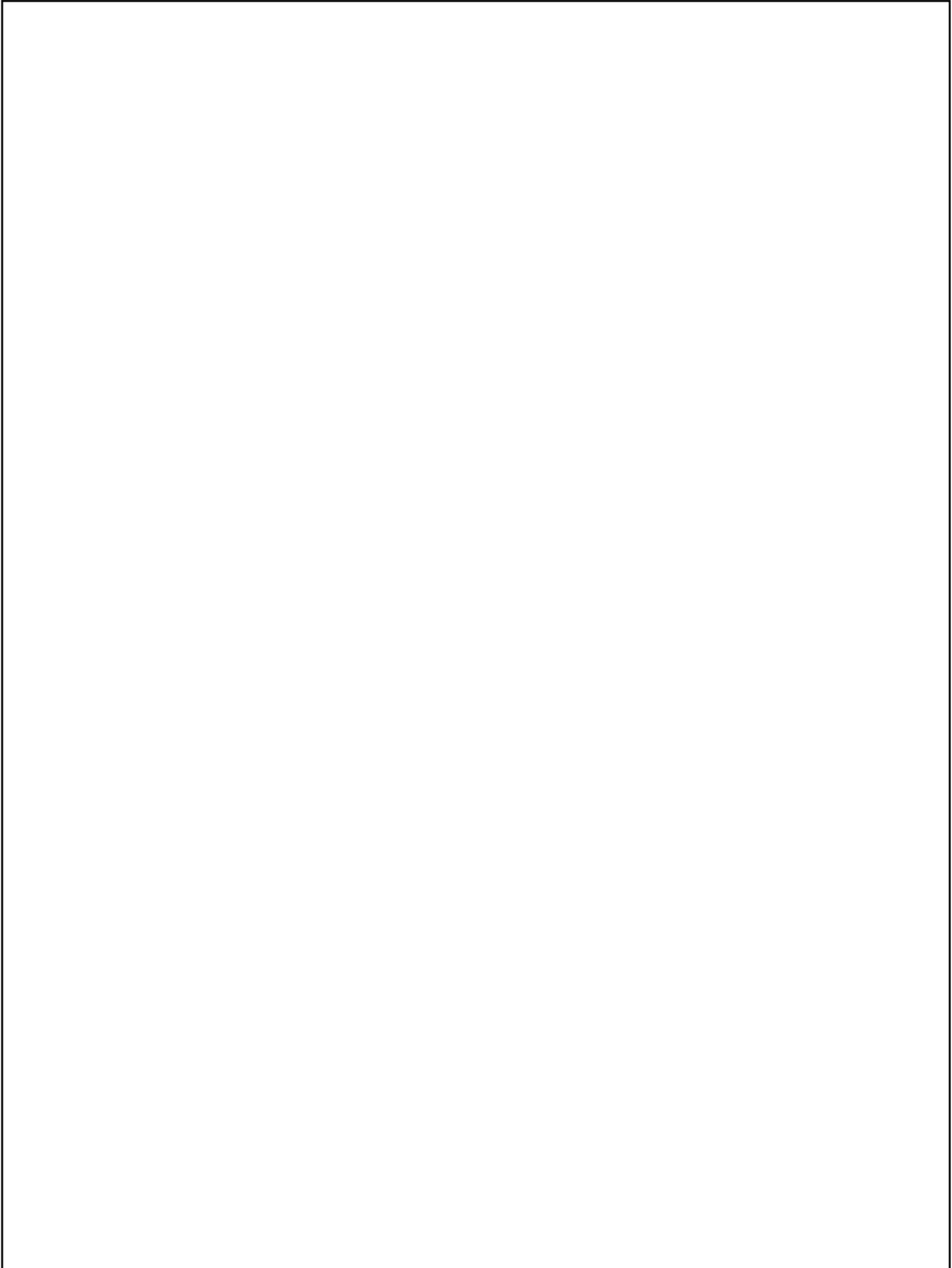



### NAPLAN Proficiency



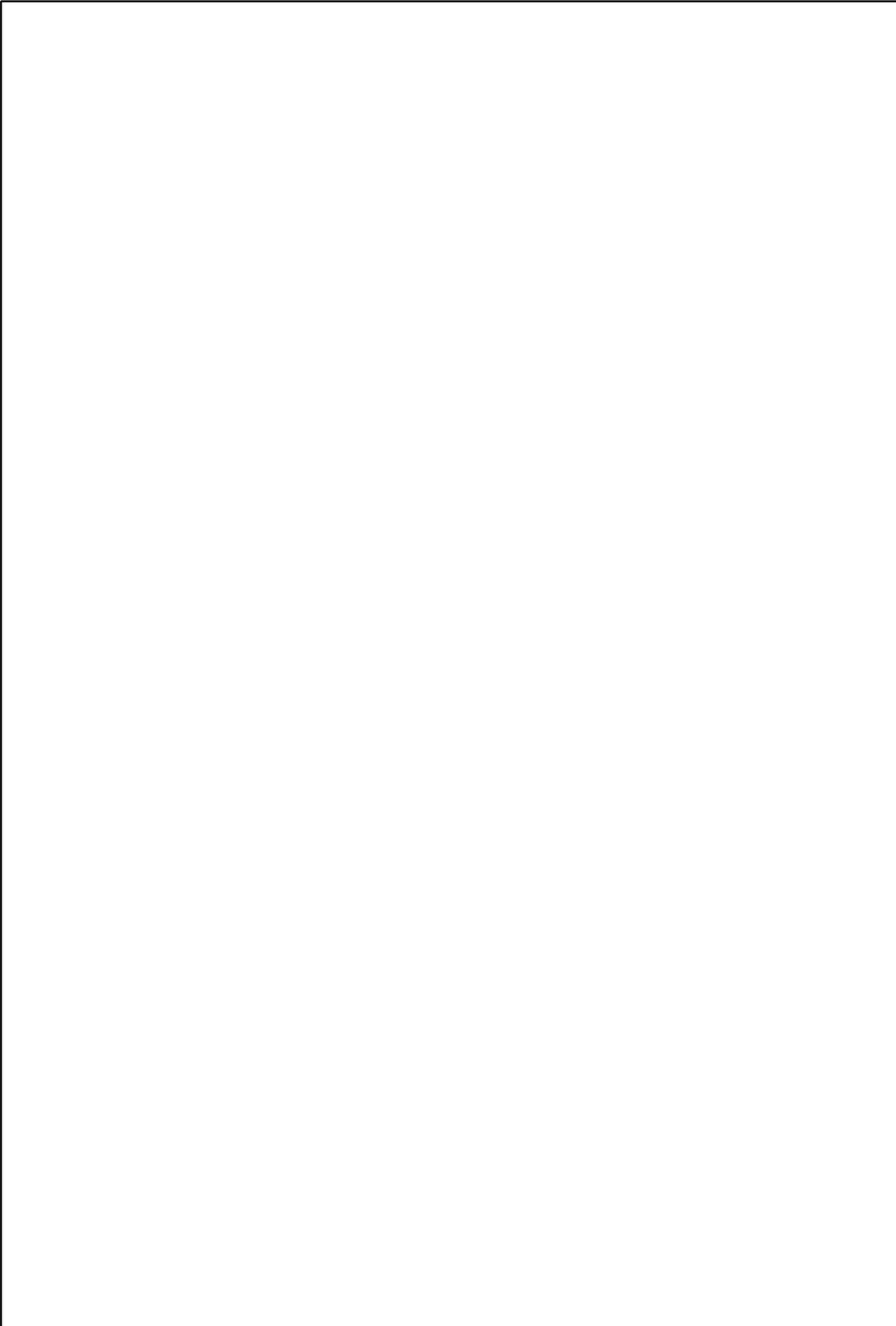
